## Crunch time for shisha smoking in Church Lane

The fate of the Oasis restaurant in Church Lane, N2, is hanging in the balance. Unless his appeal against a council enforcement notice is successful, the owner will have to demolish the shisha smoking canopy structure at the back of his restaurant or face prosecution.

### Demolition too extreme

The enforcement notice was issued after Mr El Khalil Jelbauoi's application to turn the Old Alexandra pub on Church Lane into a restaurant with facilities for smoking shisha was turned down in May. The grounds for his appeal are that planning permission should be given and that demolishing the shisha area is an excessive way to overcome the objections to it.

The appeal will be heard by the Secretary of State before the end of the year. If it is unsuccessful, Mr Jelbauoi will have four months to comply.

### Strong opinions

Local people are passionate about the Oasis, for and against. One Leopold Road resident felt so strongly about it operating for three years without planning permission that she posted letters to properties in nearby streets, imploring people to object against the appeal. But another resident, who lives opposite the Oasis, said: "There have never been any problems. It acts as a beacon to those who want a cultured evening out."

### Application to and fro

In July, shortly after lodging his appeal against the enforcement notice, Mr Jelbauoi submitted another planning application to the council, this time simply

to change the use of the old pub into a restaurant. Eight of the 45 local people who objected to this proposal said they did not object to a restaurant, perhaps not realising that this was what the application was for.

Other objectors did realise, some claiming it was just a ruse, particularly as the plans still included the canopy structure where people smoke shisha. In any case the owner withdrew the application, which was supported by 20 local people.

We tried to ask Mr Jelbauoi why he withdrew an application which, if successful, would have enabled him to at least continue to run the restaurant without shisha smoking, if he lost his appeal to run it with shisha. We were told he was out of the country and unavailable for comment.
